Subject: PROCLAMATION TO KILL 10,000 PEOPLE IN
KARACHI BY DR. ZULFIQUAR MIRZA, EX-HOME
MINISTER SINDH STATED IN A TV INTERVIEW TO
'EXPRESS NEWS' ON 18TH NOV 2011 .

At the out-set, let me introduce myself. I am a political worker of MQM having long back-ground of political activities at home and abroad. At present I am Provincial Minister for Industries & Commerce, Sindh. Prior to this I have served as Interior Minister, Minister for Excise and Taxation and Minister for Culture, Tourism & Social Welfare. In the capacity of Interior Minister for approximately 3 years, I tried my level best to uphold the supremacy of law and maintain law and order in the province I also curbed illegal activities of drug mafia etc. On various occasions, the British High Commissioner in Pakistan and Consul General in Karachi personally appreciated my efforts for maintaining Law and Order.

After my brief introduction may I take liberty to bring to your notice that Ex-Home Minister Sindh, Dr. Zulfiqar Mirza is currently visiting your country. He remained Home Minister for more than 3 years. While he remained controversial at home all along, his recent statements have caused panic and polarization in the public with potential of massive blood-shed and ethnic killings. According to Dr. Zulfiqar Mirza in live statements on T.V Channels more than 300,000/- Arm Licences have been issued by him, without proper verification giving impression of owing personal armed force to promote gangsterism and terrorize the people. He was involved in kidnapping for ransom also from industrialists in Karachi and members of Hindu Community in interior of Sindh. Extra judicial killings was also his favourite game. He was also patronizing land grabber and bhatta mafia. In a Press Conference, he went to the extent that if given free hand to kill 10,000 to 15,000 workers of MQM, he can establish peace in Karachi. He has been trying to start riots in Karachi on ethnic basis. His such inflammatory confessional statements are proof unto themselves. In a speech before the House of Lords Dr. Mirza threatened that if USA, UK & Europe don't help him to curb MQM, he will seek help from Taliban.



Ostensibly, having been rejected by the civil society, media and people of Sindh, he has thought of using London for propagating extremism and vitiate the atmosphere. During his current tour to your country he is accompanied by Lord Mayor Nazeer who is arranging Press Conferences and media meetings for Dr. Zulfiqar Mirza. Last night he held a Press Conference in London, which was telecast on various channels in which he again stated that it is necessary to kill atleast 10,000 MQM workers in Karachi to maintain peace. After his statement, people in Karachi in general and MQM workers in particular have been calling our offices and demanding proper action against Dr. Zulfiqar Mirza.

Britons are peace loving people and they do not support terrorism or any illegal activity. Facilitation and use of British based media to support international terrorism against a sovereign country and peace loving people has come as rude shock to our people. Under British and European Law any facility to anybody anywhere who is provoking terrorism is against the law. Patronization of Dr. Mirza in London has created an impression that a "London conspiracy" is being hatched to start ethnic riots in Karachi in particular and Sindh in general. God forbid, if such mishap happens, the fingers may be pointed to your govt. and party.

It will be in the interest of peace and tranquility in Pakistan that Dr. Mirza is denied all forums and facilitation. His activities should be banned in Britain and Lord Nazeer should be aware that the activities of Dr. Mirza are against British Laws. It appears that his strategy is to influence the impartial investigations and proceedings in case of assassination of Dr. Imran Farooque, which should not be allowed in the fairness of justice.

Since he is an influential person and his spouse is the Speaker of our National Assembly, it is not expected that any punitive action will be taken against him in Pakistan. As such, it is requested that necessary action, as stated above, may kindly be taken against him under British Laws to pre-empt a planned human tragedy. Otherwise in case of start of riots or civil war, the future of history will be justified in laying blame of patronage on your govt. and party for the human blood that may flow on the streets as result of sinister activities of Dr. Mirza.
